- b. Comparative Air Traffic Report: Finished calendar year out up 2% in commercial and up 1% on deplane and up 2% on enplaned passengers. Up 6% in December. Down 2% for airport operations for calendar year. Down 6% in air cargo. Fuel sales slightly down 15%.
- c. Financial Report: Collected 51% of revenue and expended 48% of the budget.
