Executive Director Reports

(a) Mr. Grafton presented his monthly reports for the month of September. Leased commercial property is at approximately 906,000 square feet of floor space. Airport Operations are currently 11% over last years totals. Fuel sales were lower in first few months of this year than in 1994 and 1995. Total enplanements are estimated to be at 100,000 for the calendar year, if the rate holds up. Charter enplanements are going from 5,000 to 5,400 this month. Commercial enplanements following same historical track. Women and Minority Business purchases account for approx 30% of total purchases. Area B housing is up to 44, with 10 units coming on line; followed by another 15 units shortly after. Bayou LaTig rentals ahead of this time last year.

Mr. Bonnette shared with the board two instances where the England Authority economic development ad appeared in magazines ("Site Location" and "USA and Europe in Business 1997").
