- (a) Mr. Grafton presented his monthly reports on Leased Space which is slightly above 600,000 square feet; Air Operations are surpassing last years totals; Fuel Sales recorded for October were 430,000 gallons; Women Owned/Minority Businesses continue at 45% of total since July; 26 houses are currently leased in the Area B section, and LeTig Bayou Rentals are up due to the upcoming Holiday season.
- (b) Mr. Joe Slowinski, Director of Administration presented the Financials for the month of October, 1995.
- (c) Mr. Ronnie Hair, Director of Operations reported that Work Task I & II(Runway Improvements/Airfield Lighting) is 12% completed, Work Task III (Airport Fencing) is 35% completed, Work Task IV (Interim Terminal) 30% completed, Work Task V (Railway Spur Renovations) 57% completed, Work Task VI (Street Overlay) has been delayed until April 1996 due to heavy hauling of trucks to the construction areas. Overlay on Runway 18/36 will begin on the 26th of November.

Mr. Grafton informed members that the new Structural Pumper arrived today. The ARFF truck is being built and is due to arrive around March or April 1996. He reported to the Board Members that Industry Week magazine will be doing a story on Base Reuse. Mr. Grafton stated that a news crew from CNBC Television visited the Authority this week. They have an Industry Week television show that will be doing 8-10 minute spots featuring England and Rantoul. He further stated that a study group touring the United States is in our area for a few days. They are looking for case studies on management of large economic dislocation projects and keys for successful reuse.

Mr. Meyer briefly updated members on his recent trip to California where he spoke on the Caretaker Agreement. He mentioned that he was honored to have represented the England Authority at this conference.
