Comments or Questions by Commissioners - None

Executive Director's Report - Mr. Grafton discussed and handed out the new State advertisement for the Audubon Trail brochure; Mr. Grafton will meet with KJA to bring back in March a mock-up production calendar and budget for advertising that would address the time-line. Washington Delegation from LA - Mr. Grafton and Chairman Wayne Miller traveled to Washington to meet with Washington Delegation at the end of February. The President's budget fully funds the Stryker and the congressional delegation stated that they are in support of the project. He also discussed their support of the dormitories and the new large scale aircraft hangar. Comparative Air Traffic Report – E.A. was up 16% for the month of January (highest increase in a month). Fuel sales were up 12%. Financial Report - 58% of the fiscal year had elapsed. Have collected 53% of the revenue and expended 53.4% of the budget. Revenues are running a little behind. Expenditures are about normal for where the E.A. is for the year. Budget amendment will be brought to the board next month.
