We have made offers on six; We have four structures to be demolished and will be applying for grants over the next few years and we should be receiving a grant between \$2 to \$3 million dollars per year.
- b. Runway 18/36 Extension Team of engineers met last week and hope to have 100% design completed by end of year. Hopefully will get into the CARES ACT for funding.
- c. Airfield Electrical Rehab Pushing forward and making headway. Had good calls with Washington.
- d. Runway Safety Area Project Will be starting project in the next week or two.
