- H. Staff Report Financial Report 33% through the year with revenues holding steady at 33%; expenses are at 36%. \$248,000.00 was paid out year to date for Hurricane Laura. Without these expenses, England Authority would be at 33% on operating expenses as well. Update on Hurricane Laura: England Authority was given a summary of the proof of loss from the insurance company. Starr Surplus Lines Insurance Company are currently estimating a loss of \$2.3 million. With deductible and depreciation adjustments, England Authority will receive a little over \$1 million in advance. Damage information is still being compiled, therefore we do not have a total loss figure.
 - Comparative Air Traffic Report 40% to 50% down from last year. Airport traffic is slowly coming back. American Airlines, beginning on November 14, will be adding a fourth flight and on December 17, they will be adding a fifth flight per day.
